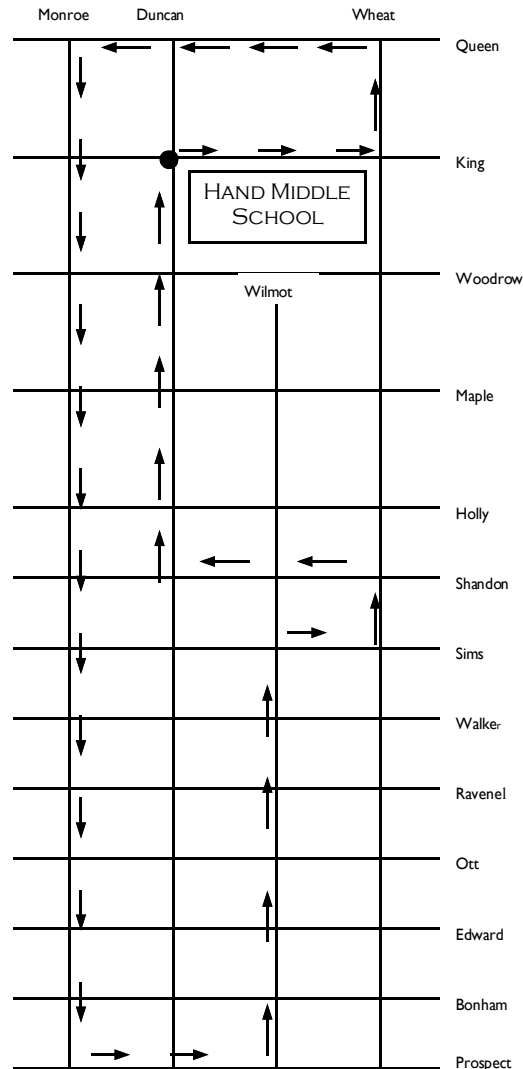
WOMEN IN LAW
